- > Health and Safety training sessions, and /or material distributions to be made to all company personnel as recommended by the findings of the safety committee, OSHA, or other health and safety sources. Management and committee members will conduct an annual review of progress made and/or needed in the area of health and safety. Jasper Group encourages all personnel to make discovery and communication of potential health and safety hazards a part of their everyday responsibilities.
- > Active involvement and cooperation of Upper Management Personnel in supporting all Health & Safety programs, and in communicating with plant personnel.
- > The safety director will assign responsibilities and improvement projects to selected personnel and work closely with all employees and safety committee members in developing new programs and in making existing programs more effective and more efficient.
